

Terms of Service

The Mothership Network

Last Updated: March 2, 2026

These Terms of Service (“Terms”) govern your access to and use of The Mothership Network (“Company,” “we,” “our,” or “us”), including our website, services, content, features, and any related platforms (collectively, the “Services”). By accessing or using the Services, you agree to be bound by these Terms. If you do not agree, you must discontinue use immediately.

1. Eligibility

You must be at least 18 years old to use the Services. By using the Services, you represent that you meet all legal requirements to enter into a binding agreement.

2. User Accounts

- You may be required to create an account to access certain features.
- You are responsible for maintaining the confidentiality of your login credentials.
- You agree to notify us immediately of any unauthorized access or security breach.
- We reserve the right to suspend or terminate accounts that violate these Terms.

3. Acceptable Use

We reserve the right to remove content that violates these Terms.

5. Intellectual Property

All content provided by The Mothership Network—including logos, branding, text, graphics, software, and design—is owned by us or licensed to us and is protected by copyright, trademark, and other intellectual-property laws.

Users may not:

- Copy, modify, or distribute our content without permission.
- Use our trademarks without written authorization.
